Tort Reform Law: §766.118. Non-Economic Damages were capped at \$500,000 for practitioners; \$750,000 for non-practitioners; \$1-million for permanent vegetative state or death. Passed in 2003 but declared unconstitutional by the Florida State Supreme Court in March 2014.

Graphic Summary of Medical Malpractice Incidence and Cost for Florida from 2003-2014




Figure 1: Total number of Paid Medical Malpractice Claims for Florida from 2003-2014 for All Health Care Practitioners Combined as Well as for MD/DOs Only




Figure 2: Total Amount Paid for All Medical Malpractice Claims from 2003-2014 for All Health Care Practitioners and MD/DOs Only in Florida.




Figure 3: Figure 2 Data When Adjusted for Inflation.

Brief summary: Florida's Supreme Court threw out their cap on medical malpractice awards in march 2014. It's unlikely that would have any effect on malpractice costs for 2014. Time will tell if these costs go up over the next few years. In other States where this has happened, malpractice costs tend not to have gone up though.
