Total decrease in medical malpractice costs for all States that had tort reform laws was 29% from 2003-2013.

Decrease in medical malpractice costs for States that had caps on total or non economic damages of \$750,000 or less was 35% from 2003-2013.

Decrease in medical malpractice costs for States that had caps on total or noneconomic damages of \$500,000 or less was 38% from 2003-2013.

\*NE: Cap on non economic damages (pain and suffering only), T: Cap on total damages (often excluding ongoing medical costs), WD: Cap on wrongful death only, Pun: Cap on punitive charges only.
